



2018 Educational Scholarship Application

As part of its continuing commitment to higher education, East River Federal Credit Union is offering Educational Scholarships to its membership. Application is also available online at www.EastRiverFCU.com

Awards:

- 2 - \$1000.00 Scholarships and 2 - \$500 Scholarships
The four scholarships will be awarded to:
 - 1 – Madison High School graduating senior
 - 3 – Graduating seniors or currently enrolled full-time college, university, or vocational students.

Qualifications:

- The scholarships are open to high school seniors or currently enrolled full-time college, university, or vocational students, who are applying for or have been accepted for admission to an accredited college, university, or vocational school.
- Applicant must have a minimum overall grade point average of 2.0 or above.
- Scholarship applicant must be a current East River FCU member with an active account (for at least one year), in good standing.

Requirements:

- **Scholarship application:** must be complete and submitted with all requested supporting documents attached by the deadline.
- **Essay:** Must be typed (500 words or less).
East River Federal Credit Union's purpose is Building Success Stories with its members and community. What is your definition of success as it relates to your own life and how can the credit union help you in achieving your goals toward that success?
- **Activity and involvement:** list volunteer, community service, extracurricular, or school activities as well as jobs you have had. Include the dates of each. If offices were held, List the depth of your involvement. **(Please list on a separate sheet of paper.)**
- **References:** submit two letters of reference from a teacher, counselor, employer, or community leader with your application.
- **College acceptance letter:** college acceptance letter or proof of enrollment at a college, university, or vocational school (e.g. bill, schedule) must be submitted. If you have not yet received a letter of acceptance, obtain a letter from your counselor stating the name of the college, university, or vocational school and the date your application for admission was mailed.
- **Transcript:** A copy of your High school or most recent college transcript must be submitted.
- **Photo:** Email a recent photo to penni@eastriverfcu.com for use in East River FCU promotional materials.

Judging

Scholarship selection will be based on the following criteria:

- **Content:** All items should be typed, organized and neatly presented. Application must include all requested information and be free of grammatical errors.
- **Merit:** Community service/volunteerism involvement, academic achievement and reference letters will be considered.
- **Creativity:** Originality of the essay will be considered.

Special Requirements:

- Applicants must submit the application with all supporting documents attached by the announced deadline date. Incomplete applications will not be considered.
- Applications must be postmarked no later than **Friday, March 2, 2018**. Applications that are postmarked after the announced deadline will not be considered.
