Educational Scholarship Application

As part of its continuing commitment to higher education, East River Federal Credit Union is offering Educational Scholarships to its membership.

Awards

Six (6) \$1,000.00 Scholarships for graduating seniors or currently enrolled full-time college, university, or vocational students.

Qualifications

- ◆ The scholarships are open to high school seniors or currently enrolled full-time college, university, or vocational students, who are applying for or have been accepted for admission to an accredited college, university, or vocational school.
- ◆ Applicant must have a minimum overall grade point average of 2.0 or above.
- ◆ Scholarship applicant must be a member (not applicant's parents) in good standing for at least one (1) year.

Requirements

- ◆ **Scholarship application:** must be complete and submitted with all requested supporting documents attached by the deadline. Applications may either be neatly handwritten or typed.
- ◆ **Essay:** not to exceed 500 words, typed, answering the following: "Establishing good credit is essential for your financial future. In what ways will you work to build or maintain a good credit score and what role does East River FCU have in helping you achieve this goal?"
- ◆ **Activity and involvement:** list volunteer, community service, extracurricular, or school activities as well as jobs you have had. Include the dates of each. If offices were held, list the depth of your involvement. List on a separate sheet is necessary.
- ◆ **References:** submit two letters of reference from a teacher, counselor, employer, or community leader with your application.
- ◆ **College acceptance letter:** college acceptance letter or proof of enrollment at a college, university, or vocational school (e.g. bill, schedule) must be submitted. If you have not yet received a letter of acceptance, obtain a letter from your counselor stating the name of the college, university, or vocational school and the date your application for admission was mailed.
- ◆ **Transcript:** A copy of your high school or most recent college transcript must be submitted.
- ◆ **Photo:** Email a recent photo to the Marketing Specialist for use in East River FCU promotional materials.

Judging

Scholarship selection will be based on the following criteria:

- ◆ **Content:** All items should be organized and neatly presented. Application must include all requested information and be free of grammatical errors.
- ◆ **Merit:** Community service/volunteerism involvement, academic achievement and reference letters will be considered.
- ◆ **Creativity:** Originality of the essay will be considered.

Special Requirements

- ◆ Applicants must submit the application with all supporting documents attached by the announced deadline date. Incomplete applications will not be considered.
- ◆ **Applications must be emailed to erica@eastriverfcu.com or mail and postmarked no later than Friday, March 11, 2022.** Applications that are emailed or postmarked after the announced deadline will not be considered.
